

I, Bonginkosi Emmanuel Nzimande, Minister of Higher Education and Training, hereby, in terms of *Sections 3(4)(l) and 7 of the National Education Policy Act, 1996 (Act No. 27 of 1996)*, read with *section 43(1) of the Further Education and Training Colleges Act, 2006 (Act No. 16 of 2006)* approves an extension of the phasing out of the National N Certificates: N1 – N3 Engineering Studies). This is an amendment to Government Notice 302 in Government Gazette No. 28677 of 29 March 2006, and relates to the sections on “Repeal of Policy and Transitional Arrangements”.

The conditions of the above extensions are set out in Schedule 1.

SCHEDULE 1**Provisions governing the extension of offering of the National N Certificates: N1-N3 (Engineering Studies)**

- a) The offering of the following programmes, as listed in the *National Education Policy: Formal technical college instructional programmes in the RSA, Report 191 (2001/08), Part 1: N1 to N3* is granted extension in terms of this gazette.

- c) Students enrolled on the N1-N3 programmes must be indentured by industry prior to enrolment in the programmes listed.
